An act to add Article 3.6 (commencing with Section 78264) to Chapter 2 of Part 48 of Division 7 of Title 3 of the Education Code, relating to community colleges.

LEGISLATIVE COUNSEL'S DIGEST

AB 1417, as introduced, Frazier. Community colleges: providers of care for individuals with developmental disabilities: model curriculum for certification program.

Existing law establishes the California Community Colleges, under the administration of the Board of Governors of the California Community Colleges, as one of the segments of public postsecondary education in this state. The board of governors appoints the Chancellor of the California Community Colleges to serve as the chief executive officer of the segment. The California Community Colleges comprises 116 campuses operated by community college districts throughout the state.

This bill would express findings and declarations of the Legislature relating to the need in this state for well-trained providers of care for individuals with developmental disabilities. The bill would require the chancellor's office to develop a model curriculum for a certification program for providers of care for individuals with developmental disabilities, designed to be offered at community college campuses where there is sufficient student interest and a properly qualified faculty to sustain such a program. The bill would require the chancellor's office,

in developing the model curriculum, to consult with individuals and organizations with expertise in the provision of care for individuals with developmental disabilities and the training of practitioners for that task.

The people of the State of California do enact as follows:

8 78264. (a) (1) The Legislature finds and declares both of the
9 following:

10 (A) There is a great need in this state for well-trained providers
11 of care for individuals with developmental disabilities.

12 (B) Providing care for California's population of individuals
13 with developmental disabilities is a difficult job that requires a
14 practitioner to possess unique and specific skills in order to provide
15 the high-quality care that these individuals deserve.

16 (2) It is, therefore, the intent of the Legislature to enable the
17 California Community Colleges system to create a certification
18 program to establish a pathway for persons interested in these
19 careers to obtain the necessary preparation.

20 (b) The Chancellor's Office of the California Community
21 Colleges shall develop a model curriculum for a certification
22 program for providers of care for individuals with developmental
23 disabilities. This model curriculum shall be designed to be offered
24 at community college campuses where there is sufficient student
25 interest and a properly qualified faculty to sustain such a program.
26 In developing the model curriculum, the chancellor's office shall
27 consult with individuals and organizations with expertise in the
28 provision of care for individuals with developmental disabilities
29 and the training of practitioners for that task.
